

Definition of Non-Local Applicant

Non-local applicants are defined as persons entering Hong Kong for the purpose of education holding any of the following visa/entry permit issued by the Director of Immigration of HKSAR Government:

- Student visa/entry permit;
- Visa under the Immigration Arrangements for Non-local Graduates; or
- Dependent visa, who are aged 18 years old or above when they were issued with such visa.

Those who do not belong to this category will be considered as local applicants.
